5. To attend all Council meetings unless extenuating circumstances do not allow (in which case a telephone message or email to the School Council Chair is requested)
6. To prepare for each Council meeting by reading the agenda, minutes and any items that are circulated in advance of the meeting
7. To complete duties as assigned by the Council
8. To bring concerns to the Council meeting or if necessary to the administrative team (as opposed to approaching other staff members "on behalf of the Council")
9. To refrain from inappropriate discussion of Council business outside of meetings
10. To attend school functions whenever possible

Alberta Personal Information Protection Act

Statutes of Alberta, 2003 Chapter P-6.5 (Current as of July 1, 2012)

Protection of Personal Information:
